i.	Assistant Engineer (Elec.)	Should possess/acquired BE of a recognized University or AMIE (India) qualification in Electrical / Electrical & Electronics.
ii.	Assistant Engineer (Civil.)	Should possess/acquired BE in Civil Engineering of a recognized University or Equivalent qualification or pass in AMIE sections A&B (Civil).
iii.	Assistant Accounts Officer	Should possess/acquired M.Com/MBA (Finance) of a recognized University or pass in ICWA/CA.
iv.	Junior Engineer (Elec.)	Should possess/acquired Diploma in Electrical Engineering of a Polytechnic of the State of Karnataka.

- i. Candidates possessing qualification in disciplines/branches other than what is specified above need not apply.

#### 3. ELIGIBILITY:

a) Candidates who have obtained the minimum percentage of marks as prescribed below in respective qualifying examinations only are eligible to apply for these posts.

## 4. AGE:

The candidates should have attained the age of 18 Years as on the last date fixed for receipt of application and shall not be more than;

- i. 35 Years in case of General Merit candidates.
- ii. 38 Years in case of Category IIA, IIB, IIIA, IIIB Candidates.
- iii. 40 Years in case of SC/ST and Category I candidates.
- (a) For Ex-military Personnel (Ex-MP), the above age limit is relaxable by 3 Years plus the number of years of service rendered by them in the Armed Forces of the Union of India not exceeding 45 Years of age on the last date prescribed for receiving the application.
- (b) In respect of in-service employees, the upper age limit is relaxable by the number of years of continuous service rendered in Corporation, subject to a maximum of 7 years.
- (c) The candidates who were appointed directly on contract basis (not engaged through an Agency) by KPTCL/ESCOMs and other Public Sector Electricity Utilities in the areas of Transmission / Distribution and with work experience of minimum 5 years and above, the age limit shall be relaxed by Five (5) years over the age limit prescribed for applicants for direct recruitments.

#### 5. APPLICATION FEE:

The application fees prescribed for applying to the said posts is as follows:

- i. ₹500/- (Rupees Five Hundred Only) in respect of candidates belonging to General Category and Category I, IIA, IIB, IIIA, IIIB.
- ii. ₹300/- (Rupees Three Hundred Only) in respect of candidates belonging to SC/ST category.

Note: Physically challenged candidates are exempted from payment of application fee, however the relevant certificate will have to be produced when called for.

## 6. SUBMISSION OF APPLICATION:

- i. Applications should be submitted strictly 'ON-LINE' by logging on to KPTCL website <a href="www.kptcl.com">www.kptcl.com</a>. Applications will not be accepted by any other mode.
- ii. The website will be kept open for submitting online applications from 25.04.2015 to 15.05.2015. The last date for submission of online application is 1700 hours (5.00 p.m.) of 15.05.2015.
- iii. Before filling up the online application forms, the eligible candidates shall go through instructions made available in the website.

- iv. Candidates intending to apply for the posts earmarked for H-K Region as per Article 371(j) have to make a separate application and the prescribed application fee also has to be paid separately. The candidates claiming H-K reservation have to upload the relevant certificate issued by the Competent Authority.
- v. Candidates are allowed to apply only once and application once submitted cannot be altered under any circumstances.
- vi. Application fee is payable through any **Post Office** in the jurisdiction of Karnataka. In addition to the prescribed Application Fee, an additional amount of ₹12/- (Rupees Twelve Only) will have to be added as service charges of Postal department. The candidates should pay the Application fee at any of the Post Offices in the jurisdiction of Karnataka during working hours between 25.04.2015 to 16.05.2015 only.
- vii. After submitting the application ONLINE, the candidates should obtain the print-outs of Post Office challan and should pay the application fee at any Post Office in the jurisdiction of Karnataka and furnish the same as and when called for.
- viii. Last date for payment of application fee at Post Office is 16.05.2015.

#### 7. SELECTION:

Recruitment to these posts will be made by selection strictly on merit based on the marks secured in the **Online Aptitude Test** only, duly following reservation policy of Government of Karnataka.

#### 8. APTITUDE TEST:

An online Aptitude Test of two (2) hours duration will be conducted for 100 marks with multiple choice answers. Each question will carry One (1) mark. There will be negative marking and 0.25 marks shall be deducted for each wrong answer. There will be no marks for unanswered questions.

The online question paper will be in English version only.
